Part 1

Park Rules and Regulations

§16-101. Parks.

Ivyland Common, the Borough land situate on Jacksonville Road (hereby designated Ivy Glen Park) (formerly referred to as the Dam Area Park), and Ivyland Village Square are hereby established as Ivyland Borough parks for the purposes of recreation and the preservation of open space. A full description of the Ivyland Common premises is attached hereto and made a part hereof as Exhibit 16-1-A. A full description of Ivy Glen Park is attached hereto and made a part hereof as Exhibit 16-1-B. A full description of Ivyland Village Square is attached hereto and made a part hereof as Exhibit 16-1-C.

§16-102. Definitions.

Board-the Park and Recreation Board of Ivyland Borough.

Parks—the Ivyland Common located on Wilson Avenue in the Borough of Ivyland, the Dam Area Park and Ivyland Square. [Ord. 2011-3]

§16-103. Requirements for Use of Grounds and Facilities.

- 1. Use of the parks shall be limited to residents of the Borough of Ivyland and their guests when accompanied by a resident of Ivyland Borough. It shall be unlawful for a nonresident of Ivyland Borough to use or be present on park premises unless accompanied by a resident of the Borough of Ivyland.
- 2. Each person, firm or corporation using the parks and grounds shall clean up all debris, extinguish all fires when such fires are permitted, and leave the premises in good order, and the facilities in a neat and sanitary condition.
- 3. Use of the parks shall be on a first-come, first-served basis. The parks or areas of the parks may be reserved for specific times only upon authorization of Borough Council. Organized athletic events including, but not limited to, games and practice sessions, may be conducted on park premises only upon authorization from Borough Council.

§16-104. Prohibited Acts Within Park Boundaries.

It shall be unlawful for any person, firm or corporation using the parks to either perform or permit to be performed any of the following acts:

A. Willfully mark, deface, disfigure, injure tamper with or displace or remove any buildings, bridges, benches, fireplaces, railings, paving or paving material, public utilities or parts or appurtenances thereof, signs, notices or plaque cards whether temporary or permanent, monuments, stakes, posts, or other boundary markers, or other structures or equipment, facilities or park property or appurte-

nances whatsoever, either real or personal.

- B. Throw, discharge, or otherwise place or cause to be placed in the waters of any fountain, pond, lake, stream, or other body of water in or adjacent to any park or any tributary, stream, storm sewer, or drain filling into such waters, any substance, matter or thing, liquid or solid, which will or may result in the pollution of said waters.
- C. Bring in or dump, deposit or leave any bottles, broken glass, ashes, paper, boxes, cans, dirt, rubbish, waste, garbage, or refuse: or other trash.
- $D. \quad Disturb \ the \ peace, or \ use \ any \ profane \ or \ obscene \ language \ or \ blasphemous \ language.$
 - E. Endanger the safety of any person by any conduct or act.
 - F. Engage in fighting.
 - G. Carry, possess, or drink any alcoholic beverage in any park. [Ord. 1982-3]
- H. Prevent any person from using any park, or any of its facilities, or interfere with such use in compliance with this Part and rules applicable to such use.
 - I. Ride any horse or bring any horse upon the park grounds.
 - J. Light any fire. [*Ord. 2011-3*]
- K. Bring any motorized vehicle including, but not limited to, snowmobiles, motorcycles and cars, in any park, or to park or leave any such motor vehicle on park grounds, except as authorized by Borough Council.
- $L. \quad Destroy, deface \ or \ remove \ any \ trees, plants, shrubs, natural \ vegetation, or \ wildlife.$
 - M. Dig or remove any dirt.
- N. Construct or install equipment of any type, whether of a permanent or temporary nature, on park grounds,
- O. Conduct or participate in organized athletic events, including, not limited to, games and practice sessions, without the specific authorization of Borough Council.
- P. Permit any dog on the park grounds, whether under control of the owner or not, or permit any dog to deposit wastes on the park grounds. [*Ord. 1982-3*]

§16-105. Hours of Operation.

- 1. The parks shall be open daily from sunrise to sunset; shall be unlawful for any person or persons to occupy or be present in the said parks during the hours between sunset and sunrise, unless otherwise authorized by resolution of the Borough Council.
- 2. Any section or part of the parks, may be declared closed to the public by resolution of Borough Council at any time and for any interval of time, either temporarily or at regular stated intervals.

§16-106. Signs.

It shall be unlawful for anyone to paste, glue, tack or otherwise post any sign, plaque, advertisement or inscription whatsoever within the parks, nor shall any person or persons erect or cause to be erected any sign whatsoever on any public lands or highways or roads along the boundary line of a park; provided, however, that this provision shall not apply to any properly authorized government official in pursuit of any official duty.

§16-107. Penalties.

Any person, firm or corporation who shall violate any provision of this Part, upon conviction thereof, shall be sentenced to a fine of not less than \$25 nor more than \$1,000 plus costs and, in default of payment of said fine and costs, to a term of imprisonment not to exceed 30 days. Each day that a violation of this Part continues or each Section of this Part which shall be found to have been violated shall constitute a separate offense.

Appendix 16-1-A□ Ivyland Common

ALL THAT CERTAIN LOT OR PIECE OF GROUND, situate in the Borough of Tyyland, County of Bucks and Commonwealth of Pennsylvania, bounded and described according to a survey made by Russell J. Lyman, Registered Professional Engineer, dated May 7, 1965 as follows:

BEGINNING at a point at the intersection of DuBois Avenue and Wilson Avenue; thence crossing the bed of Wilson Avenue, along lands of now or late George S. Hobensack, Jr., and remaining lands of the School District of the Borough of Ivyland, south thirty-seven degrees fifteen minutes west three hundred twenty-two and ten-hundredths feet to a point in the center line of Willard Avenue; thence extending along the line of Willard Avenue projected, north fifty-one degrees forty-one minutes west two hundred seventy-six feet to a point in the bed of Pennsylvania Avenue; thence along the bed of Pennsylvania Avenue, north thirty-seven degrees thirty-four minutes east three hundred twenty and fifty-eight hundredths feet to a point at the intersection of Wilson Avenue and Pennsylvania Avenue; thence along the bed of Wilson Avenue, north fifty-two degrees zero minutes east two hundred seventy-four and eighty-two hundredths feet to the point and place of BEGINNING.
